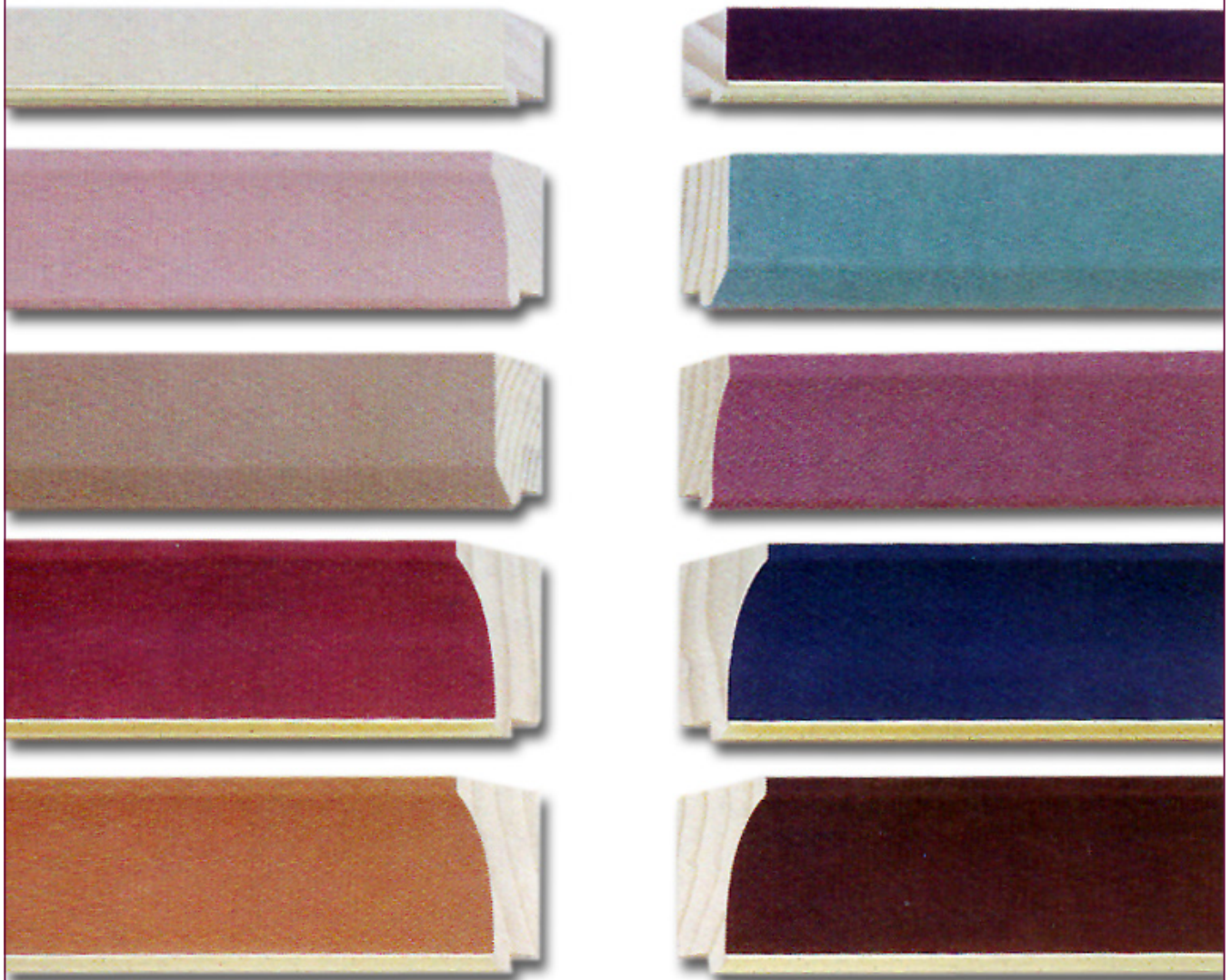

Thank you for your business. As you know, Linen Liners, Inc. manufactures a wide variety of liners, fillets, and stretcher bars for the wholesale picture framing industry. From the beginning, Linen Liners has focused on manufacturing unique product lines designed by you, the distributors and manufacturers that are our loyal customers. We value the opportunity to work with you and continue our goal to exceed your expectations of quality, service and variety.

Manufacturing:

Our manufacturing processes include milling, laminating, fabric wrapping, foiling, embossing, distressing, and finishing. We also offer the largest selection of stock liner profiles, fabrics, foils and other decorative materials available. Nearly all these materials are interchangeable with one another combining for a seemingly endless variety of products. Because it is impractical to list every moulding we are capable of manufacturing, we encourage you to contact us if you require moulding manufactured and decorated to your own specifications.

Minimum Orders:

All finished mouldings are bundled in see through reusable polyethylene tubes. Mouldings larger than one inch are packaged 20 feet per bundle. Mouldings one inch and smaller are packaged 40 feet per bundle. Fillets are packaged 100 feet per bundle. Bundles and cartons can be labeled with your company's name and stock number if desired.

Special orders:

To accommodate the occasional necessity for a special order you may have your order cut to be shipped via UPS. There is a handling charge of \$12.60 for cutting and packaging. UPS will accept a maximum length of eight feet.

Custom Milling/Moulding:

Custom mouldings can be produced in minimum quantities of 2,000 lineal feet.

Lead Times:

All liner mouldings are built to order. Although our lead time can be as few as two to three days, please allow seven to ten working days for the completion of your order unless otherwise expressed.

Samples:

Sample sets of any selection are available for \$1.25 per corner sample plus shipping. Upon request, each corner sample can be labeled with your company's name, stock number and fitted with a Velcro hanger. Sample sets can be shrink wrapped on trays and individually boxed.
